



One country one tax has drawn the attention of various political parties, stakeholders: entrepreneurs, organized and unorganized business sector, media houses and investors.

The long- delayed implementation of the Goods and Services Tax (GST) had become functional from 1st July 2017 in India. Union Finance Minister while finalizing GST rates hoped that it would transform third largest Country of Asia into a single market and boost revenue through better compliance. The Goods and Service Tax is an all-inclusive tax that would not only affect manufactures, sale and consumption pattern of goods and services but also change whole economic environment of the country. The basic objective of GST is to make uniform the scattered indirect tax system in India and avoid the cascading effect in taxation to some extent. Trade unions of Cloth, Readymade garments and Gems & Jewellery business houses opposed the implementation of the GST. Non ruling Political parties supported them and have demanded to reduce tax burden and simplify the procedures of GST. Ruling political party leaders are emphasizing and arguing that this will prove unique and the biggest economic reform, which will accelerate economic development in long term and increase Foreign Direct Investment in the country. Exemptions of many items from GST will reduce tax burden on consumers. The shifting of earlier achiac previous tax regime and carry forwarding of input tax credits in GST is a boon for trade and industry which will ultimately check the tax evasion and increase revenue of state- exchequer. Stakeholders understanding of

GST provisions and its impact is still at a nascent stage. GST is both a challenge and opportunity for tax administrators and accounting professionals.

For the purpose, information education and communication in this regard is necessary. The main objective of this seminar is to provide common


platform to share, exchange, discuss, highlight, increase awareness and educate about the benefits, impacts, implications and emerging issues of GST in the country among academician


