## **Concept Note**

Every state has its own way of interacting with its citizens. Political Parties and Bureaucracy are most important instruments to establish bridge between state and its citizens wherein the convergence of governance, civil society and development has crucial importance. The performance of different states is being judged by comparison with other states in delivering quality services and goods to its citizens through good governance. It is therefore, necessary that interaction among the state, private sector, civil society and its citizens must be analyzed for greater understanding and visualizing future direction of development and governance.

The states strive hard to achieve the sustainable level of development which is considered as an indicator of good governance. Development Administration plays a lead role in formulation and execution of welfare policies, establishing infrastructural facilitates and timely redressal of citizens grievances. Governance is measured by analyzing the quality of service delivery with corruption free bureaucracy, protection and exercise of individual rights and public accountability. At this juncture, state has to own and share its responsibility with non-state organizations and civil society. Such a sharing

of responsibility generates synergy among development, governance and civil society under the aegis of state leading to overall development of the nation.

The Department of Public Administration, University of Rajasthan will provide an opportunity to discuss the thematic conceptualization of relationship among Development, Governance and Civil Society.
