The post-construction Anti-Termite shall consist of through insecticidal spray and backed up by 2 years guarantee. Contractor has to use Chlorphyrophos 20% EC + sypermethrin + dichlorvos chemical. If any time within the said period re-infestation of the termite occurs the firm will treat that without extra payment. Chemical will be injected into the ground by means of holes made at the junction of wall and floors at 2ft. distance on the ground floor and other area. These holes shall be made by 12mm diameter drills bits 4" to 5" by drill machine and be repaired by firms and sealed by cement. All wooden doors frames and windows frames also be treated with insecticidal spray estimated area for Anti-Termite Treatment is 17000 sq. ft. approximately.
